1 RULES

The races will be governed by *the rules* as defined in *The Racing Rules of Sailing 2017-2020*.

2 CLASS

The regatta will be sailed in Ideal-18s.

3 TEAM

3.1 Each competing yacht club shall consist of a team comprised of 3 skippers who must be members or spouses of members of the club that they represent. No crew substitutions will be permitted without prior written request and approval by the Principal Race Officer or Event Chairman.

3.2 All sailors shall be at least 12 years old on or by June 2, 2018

3.2 Teams shall wear bibs outside of their PFDs. Teams are encouraged to bring their own bibs. For those teams that do not have their own, they will be provided by the organizers.

4 ELIGIBILITY AND ENTRY

4.1 Clubs may enter on approved entry forms received by Riverside Yacht Club by **May 11, 2018**.

4.2 A maximum of six teams will be allowed to compete and final decision on the teams will be at the discretion of Riverside Yacht Club.

5 FEES

Entry fee for the event will be \$275 per team.

7 RACING AREA

The racing area will be in the waters of Captain's Harbor or inside by Riverside Yacht Club.

8 SAILING INSTRUCTIONS

Sailing instructions will be available at the Competitors' Meeting.

9 FORMAT

Format will be at the discretion of the Race Committee.

10 SCORING

10.1 Scoring will be in accordance with Appendix D, except as modified by the sailing instructions.

10.2 The winner shall be determined by each club's finishing positions, low total wins. The other clubs shall be ranked in a similar fashion. Ties shall be broken using the greater number of race wins if necessary, Rule D4.2.

- 10.3 This event will not be umpired.
- 10.4 Protests will be resolved using 3-minute justice.

12 LIFE JACKETS

All competitors shall wear a U.S. Coast Guard-approved PFD at all times while on the water except for brief periods when changing or adjusting clothing or equipment.

13 WAIVER AND DAMAGE FEE

All participants must sign a waiver form regarding personal injury and borrowed boat responsibility at registration. A damage fee of up to \$500 may be charged to a skipper's credit card if there is damage to a boat. A credit card must be presented at registration for the damage fee. If the Protest Administrator, the Race Committee, or the Event Chairman determines that the Right of Way skipper did not act appropriately to avoid a damage-causing collision, the cost to repair the damage may be divided between the two skippers involved.

14 CONDUCT AND RESPONSIBILITY

- 14.1 The skipper shall be responsible for all actions of his or her crew or guests. In the event of a breach of conduct, sportsmanship, destruction of property or failure to comply with the request of any race officer, committee member or agent of Riverside Yacht Club, the skipper will be held responsible.
- 14.2 Riverside Yacht Club is not responsible and will not accept any liability for bodily injury, death, or property damage suffered from any cause. Each participant, including skipper and crew, participates in the regatta entirely at his/her own risk and waives any and all claims, including those arising from negligence or lack of due care, which he/she may have against the Riverside Yacht Club, its regatta committee, and its officers, trustees, committee members, members, agents, or employees. Responsibility for evaluating the wind, sea, and other conditions rests with each participant as does responsibility for the safe condition of the boat, including safety equipment and rigging and for deciding when to wear life jackets. Patrol boats or other assistance will not likely be available. Assistance, if any, from the regatta committee or other Riverside Yacht Club vessels, or other patrol boats, from any personnel manning them, is entirely at the risk of the participant.
