## Notice of Race

- Riverside Yacht Club is the Organizing Authority (OA) in partnership with the Junior Sailing Association of Long Island Sound.
- **[DP]** The notation '[DP]' in a rule means that the penalty for a breach of the rule may, at the discretion of the protest committee, be less than disqualification.

## 1 RULES

- 1.1 The event will be governed by:
- a. the rules as defined in *The Racing Rules of Sailing*
  - b. the Optimist Class Rules
  - c. the [Rules for JSA Events](#)
  - d. the [JSA Code of Conduct](#)
  - e. the US Sailing [Athlete Safety Handbook](#)
  - f. RRS Appendix V1 Penalty at the Time of an Incident, and Appendix V2, Penalty Taken After a Race, will apply.
  - g. RRS Appendix T, Arbitration will apply

## 2 SAILING INSTRUCTIONS

- 2.1 The Sailing Instructions will be available at [Insert Clubspot Link here](#) before and during the regatta.

## 3 COMMUNICATION

- 3.1 This Notice of Race, results, and other information will be available at [Insert Clubspot Link here](#).
- 3.2 [DP] Each coach and support vessel shall carry a VHF radio capable of communicating on all US channels. Blue/Red Circle intend to communicate on VHF 69 and White Circle on 65A.

- 3.3** [DP] All coaches and support vessels shall monitor VHF channel corresponding to their circle. Support persons shall maintain silence on this channel unless safety-related communication with the race committee or safety patrol is necessary. Riverside Yacht Club base can be reached on VHF channel 74 for operational and emergency support.
- 3.4** [DP] While racing, from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication not available to all boats.

## **4 ELIGIBILITY AND ENTRY**

- 4.1** This regatta is open to all female competitors who meet JSA and regatta eligibility requirements.
- 4.2** The regatta is open to JSA members' racing the Optimist. Participants must that meet the age requirements set forth below and who have also been certified as competent for this event by, and are under the responsibility of, the Head Instructor or Program Chair of the Junior Sailing Program at their club, or a similar competent organization.

Competitors shall be divided into three groups according to their ages on the first day of the scheduled competition, as shown above.				

- 4.4** Eligible boats may enter by registering online at [Registration Link](#). To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

## **5 MEASUREMENT, SAFETY AND EQUIPMENT**

- 5.1** Each boat shall carry the safety equipment specified by either the Optimist Class Association or JSA.
- 5.2** Each sailor shall complete a safety check, pass such check before sailing, and present their completed self-check safety form to registration.
- 5.3** [DP] For Opti Sailors: Each boat shall display a streamer designating their Division (red, blue or white) from the top of their sail. Streamers will be provided at registration.

## **6 FEES**

- 6.1** The entry fee is \$100 per sailor due by July 3, 2025. The fee for entries submitted after the due date is \$125 per sailor. No refunds of the entry fee will be made after July 3, 2025. There is no fee to send an Instructor. The entry fee includes regatta giveaway, breakfast bar, post-race snacks, raffle and awards.
- 6.2** All skippers, crews, and Instructors are required to check in (in person) during registration.

## 8 VENUE

8.1 The racing area will be Captain's Harbor

## 9 COURSES

9.1 The course to be sailed will be as described in the Sailing Instructions.

## 10 SCORING

10.1 One race is required to be completed to constitute a series.

10.2 When fewer than four (4) races have been completed, a boat's series score will be the total of her race scores. When five (5) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score. This changes RRS A2.1.

10.3 The Red and Blue age groups will start together and be scored overall. The White age group will start and be scored separately.

## 11 PRIZES

11.1 Prizes will be awarded to the top three finishers in each class.

11.2 Equal Prizes will be awarded to helm & crew positions

11.3 A sportsmanship trophy may be awarded at the discretion of the race committee and informed by the written submissions of the competitors.

## 12 SUPPORT VESSELS

12.1 Any program entering three or more boats shall supply an instructor with a support vessel equipped with a working VHF radio, an anchor and a first aid kit.

12.2 Any program entering fewer than three boats that will not supply a support vessel shall arrange with another program to allow the supervising instructor out onto the water. In no circumstance shall competitors be allowed to sail without a designated instructor on the race course.

12.3 [DP] All support vessels shall be equipped with a functioning engine safety cut-out switch (kill switch) which shall remain attached to the operator at all times while the engine is running.

12.4 [DP] Instructors shall register with the OA at registration.

12.5 [DP] Instructors shall attend the instructors' meeting to receive safety assignments.

- 12.6** Each designated instructor is responsible for ensuring every sailor under their supervision is accounted for prior to leaving the racing area.

**13 DRONE USAGE**

- 13.1** Drones are not allowed at the event unless they are authorized by the Organizing Authority (OA). Content from OA authorized drones should not be used for coaching during the event. If the content is used for coaching (or other similar purposes) it shall be made available to all competitors at the same time and not during competition hours. Further, the content shall be made available to the JSA for promotional purposes by promptly emailing said content to [news@jsalis.org](mailto:news@jsalis.org).

**14 TRANSPORTATION AND PARKING**

- 14.1** [DP] Neither competitor nor coach boats may arrive before July 13,2025.
- 14.2** [DP] Coach boats that arrive by water should contact the Dock Master on VHF channel 74 for docking instructions.
- 14.4** [DP] Coach boats shall not launch by hoist without assistance from Riverside Yacht Club staff.

## 15 RISK STATEMENT

- 15.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**
